## Appendix A

**Subject :** North Yorkshire Villages and Towns Petition for Average and Fixed Cameras – "Cameras for North Yorkshire" (or some other campaign name)

## Dear Mr Skaith

We, all the towns and villages named above, are writing to you to request action on a matter which is of *serious concern* to not only the villages who are signatories to this letter, but many other villages in North Yorkshire.

Every one of the villages who have signed up to this letter experience the same problem, that being horrendous speeding and anti-social driving through and around our villages and towns.

North Yorkshire is only one of two police forces that does not make use of average and fixed speed cameras, relying solely on mobile speed cameras. Regardless of claims made about the efficacy of mobile speed cameras, which we who live in these villages dispute, the following facts cannot be disputed;

- There are only 14 mobile vans for the entire County
- They are effective when they are present
- Once they are gone, the speeding resumes immediately
- We have yet to see them operate at night and in the early hours of the morning

## This means that speeding motorists have to be extremely unlucky to be caught!

#### What are our neighbours doing?

The neighbouring Counties of West Yorkshire, Lancashire and Cumbria have all rolled out average speed cameras through village areas, and these all stop at the North Yorkshire border.

An incorrect claim was made by the North Yorkshire Police to the previous PFCC, Zoe Metcalf, in a Public Accountability meeting stating that neighbouring counties were moving away from Fixed and Average speed cameras in favour of mobile cameras. Both West Yorkshire and Lancashire replied to a letter confirming this was not correct and that mobile cameras are in fact only used to support their road safety strategies but are not the driving strategy.

#### What has been done in our villages?

We all have some sort of vehicle activated technology in place - (VAS, VAR, SID) but without enforcement these are essentially rendered useless. Community Speed Watches have been set up in some villages, with results so eye-watering in the case of Cowling the police agreed to take over the responsibility of policing speeding, but without enough feet on the ground, this is simply not working.

In some cases, a reduction in speed on the approach to a village was implemented by Highways, extra bollards erected in the middle of the village, road markings repainted – but nothing has helped. In fact, overtaking on the wrong side of bollards is common-place.

Without consistent and effective enforcement nothing, nothing will address these issues

## The fact is motorists who want to speed, will if they can. And they can in North Yorkshire.

#### Evidence

The villages and towns have data from their Vehicle Activated devices.

The village of Cowling, also a signatory to this letter, has captured footage of speeding and anti-social driving, and this has been aired on *local and national TV and Radio channels*. Jeremy Vine thought the video had been speeded up such were the speeds witnessed. ## Is this truly the standard York and North Yorkshire aspires to? Is this a legacy to be proud of?

Please, Mr Skaith, please allow us some time to talk to you about the reality of our villages, and not the statistics presented to you from the sporadic and infrequent visits of the mobile speed units which only catch speeding drivers when they are there. Allow us to present the reality of life in a North Yorkshire village or town where it appears, to date, that the concerns of residents are to be ignored, trivialised and swept aside.

Dear Mayor, Deputy Mayor and Town Councillors

I write once again to provide an update about our ongoing work to establish the extent and character of possible PFAS contamination in and around the factory site.

Again, I want to emphasise that we consider this matter to be of the utmost importance. We remain committed to gaining a full understanding of the issue and then to providing appropriate remediation, in agreement with the Environment Agency. Please contact me if you have any questions.

- As communicated last month, pending the initial PFAS testing results, we asked Ramboll to move forward and undertake the second phase of soil and groundwater samples both onsite and offsite. Ramboll undertook this work in the week commencing 29<sup>th</sup> July. This will provide us all with more analytical data to discuss at the next meeting with the Environment Agency. It should make it easier and quicker to determine any data gaps and where the next phase of PFAS testing should take place.
- Ramboll have advised that they will be in a position to issue the results of their soil and groundwater testing during the week commencing 2<sup>nd</sup> September.
- Angus intends at that point to communicate quickly and directly with people and/or groups that
  may be impacted by the results. I reiterate that we will keep you informed about these
  communications and consult with you about any near-term remedial work that may be necessary.
- We will continue to update the local community via the microsite <u>www.derbs.co.uk</u> and other channels where necessary. This will be in a timely manner, although we still think it is right and proper to communicate first with any parties that are directly affected.
- Our investigation into surface water filtration technologies continues, and we have now engaged the services of Geosyntec Consultants (<u>www.geosyntec.co.uk</u>). Like Ramboll, they are an Environmental consulting and engineering firm that works to address complex problems involving our environment, natural resources, and civil infrastructure. Geosyntec will work alongside Ramboll to evaluate and develop the engineered solution required for the Bentham site. Our goal is still to have something in place in the next few months. No ready-made solution is available on the market but we intend to develop a customised solution via a combination of different technologies. In the meantime we continue to collect rainwater/surface water run-off from the concrete surfaces at the redundant foam plant and the fire test site.

As we progress through this work, we will continue to provide you with regular updates. We are mindful of our positive relationship with the local community, and preserving that is of paramount importance to us.
